Each unopposed candidate shall be deemed to have voted for him or herself.

If three or more candidates qualify for a council ward, those candidates' names will be placed on the Primary Election ballot; if one candidate in the Primary Election receives the majority of votes cast that candidate is declared elected. If no candidate receives a majority of the votes, then the two candidates receiving the highest number of votes will be placed on the General Election ballot. The names of unopposed candidates shall not appear on the ballot. Each unopposed candidate shall be deemed to have voted for him or herself.
