<sup>(2)</sup>4% fee = 4% fee (1% election assessment and 3% filing fee), forwarded to the Florida Elections Commission for County Court Judge and School Board Candidate.

<sup>(2)</sup>4% fee = 4% fee (1% election assessment), forwarded to the Florida Elections Commission and (3% filing fee) to general revenue fund of the county for NPA candidate.

<sup>(3)</sup>\$25.00 filing fee in the general revenue fund of the county for independent special district candidate.
