Persons are advised that they will need a record of the proceedings if they wish to appeal any decision made at this meeting. For such purpose, they may need to ensure that a verbatim record of the proceedings is made, including the testimony and evidence upon which the appeal is based per Section 286.0105, Florida Statutes.
