The file format for data files is a text file with comma-separated values (csv). Open using Excel or a compatible database program.

Voter data identifies voters by any of the following categories (or a combination): Name, Residence Address, Mailing Address, Date of Birth, etc. Voter data may be requested for the following: Election History (1999 to present), Households, New Voters, Registered Voters, Petitions, Specific District or Geographical Area, etc.)

A special service charge will be imposed pursuant to section 119.07(4)(d), Florida Statutes, if the nature or volume of the requested public records requires extensive use of information technology resources and/or extensive clerical or supervisory assistance by agency personnel and also includes the safeguarding of agency personnel records. This charge will be separate and in addition to actual duplication and material costs.

The Supervisor of Elections will provide a requestor with a written fee-estimate and requires an advance payment of 75% (seventy-five percent) of the estimated fee prior to undertaking producing the requested records. If the requesting party subsequently advises that they will not need the records, the Supervisor of Elections reserves the right to bill for the difference between the deposit and the actual cost of copying public records. The requesting party will not receive a refund for the initial deposit.

Petition-signature verification fees may be prepaid. A shortage of funds in a prepaid signature verification account will result in postponement of signature verification until the deficit is resolved. Residual funds remaining in a prepaid signature verification account will be reimbursed to the candidate or petition sponsor upon completion of signature verification.
